#### HAZARDOUS CHEMICAL INFORMATION

Enclosed is the renewal form for hazardous material emergency preparedness service charge. This charge applies to any establishment where one or more hazardous materials are used, stored, transported, manufactured, generated, disposed of or sold at any one (1) time during the preceding year within the city. These include and are not limited to: carcinogens, pesticides, airborne contaminants, toxic: water or air pollutants ore reactive; substances which are corrosive, explosive, combustible, radioactive or unstable; strong sensitizer which generates pressure through exposure to heat, decomposition or other means.

#### **INSTRUCTIONS:**

- 1. List each hazardous material on the renewal form.
- 2. Locate each substance category on the table and enter on the renewal form
- 3. Enter the quantity of each type and enter it on the renewal form.
- 4. Affix the appropriate fee for each type and quantity.

Follow the above steps until all substances have been logged and completed. If additional space is needed list on a blank sheet of paper and attach to renewal form.

- 5. Add the fee column and enter that amount on line 10.
- 6. Calculate interest @ 1% per month until paid. Enter on line 11.
- 7. Calculate penalty @ 5% per month until paid(not to exceed 25%). Enter on line 12.
- 8. Add lines 10, 11, and 12 for total. Enter on line 13. This is the amount to be remitted.
- 9. Sign renewal, enclose check or postal money order and mail to:

Service stations engaged in retail sales of gasoline shall pay a flat rate of one hundred dollars (\$100.00) per location. (Section 24-31 of the code of the City of New Orleans).

DUE DATE: Renewals are due on or before February 28.

INTEREST AND PENALTIES: Interest and penalties are assessed beginning March 1. This renewal must be signed by sole proprietor, partner, member, or corporate officer.
