AGREEMENT

NOW COME the parties herein, through undersigned counsel, who represent that an agreement has been reached resolving the above captioned Civil Service ("CS") appeal, prior to and in lieu of proceeding with the CS hearing scheduled on November 18, 2021. The New Orleans Police Department ("NOPD") has agreed to reduce the one-day suspension issued for violation of Rule 4, Paragraph 4B, C-6, NOPD Chapter 41.5 Vehicle Pursuits, Paragraph 10 under PIB #2019-0464 to a written letter or reprimand, and Officer Poole shall be reimbursed for the one day of suspension served. However, the letter of reprimand issued for violation of Rule 4, Paragraph 4, C-6, NOPD Chapter 41.3.10 Body Worn Camera, Paragraph 10(b) under PIB #2019-0464, shall remain.

In response to NOPD's agreement to reduce the one-day suspension issued for violation of Rule 4, Paragraph 4B, C-6, NOPD Chapter 41.5 Vehicle Pursuits, Paragraph 10 under PIB #2019-0464 to a written letter of reprimand and to reimburse the one-day suspension served, Appellant has agreed to withdraw her appeal in this matter.

WHEREFORE, the parties herein, through undersigned counsel, agree to the terms stated herein as confirmed by the signature of their counsel. The parties further request that this Agreement be presented to the Commission at its next scheduled meeting.
