ORDER

The Department of Property Management has moved for summary disposition on the basis that Ms. Nichols has no right of appeal as a probationary employee. The Commission heard oral argument on this motion at its May 18, 2023, regular meeting. The Commission grants the Department of Property Management's Motion for Summary Disposition, as Ms. Nichols was a probationary employee who did not assert a discrimination or whistleblower appeal. Ms. Nichols' one-year probationary period began on September 25, 2022, and the Department of Property Management terminated her employment on February 27, 2023.

Therefore, Ms. Nichols has no right of appeal under Rule II, § 4.1.
