AGREEMENT

NOW COME the parties herein, through undersigned counsel, who represent that an agreement has been reached resolving the above captioned Civil Service ("CS") appeals, CS 9307 (ER Suspension) and CS 9438 (21 working days suspension) prior to and in lieu of proceeding with the CS hearing scheduled on March 24, 2023. The New Orleans Police Department ("NOPD") has agreed to rescind the fourteen (14) days of Emergency Suspension without pay Hoffacker served from September 5, 2021 thru and including September 23, 2021, issued under PIB # 2021-0498-P and appealed under CS 9307. Specifically, NOPD will remove the September 3, 2021, notice of emergency suspension and the September 24, 2021 notice of reinstatement from Hoffacker's personnel file, reimburse Hoffacker for the fourteen (14) working days of suspension, including holiday pay and all emoluments associated with this reimbursement.

Additionally, the twenty-one working day suspension issued under PIB #2021-0498-P, and appealed under CS 9438 will be reduced by one day, specifically, the one day suspension issued for unprofessionalism, maintaining the twenty (20) working day suspension issued for violation of Rule 2, Moral Conduct, paragraph 1, Adherence to Law, City of New Orleans

Municipal ordinance 54.96 - Simple battery, under PIB #2021-0498-P, and appealed under CS 9438.

In response to NOPD's agreement to resolve this matter as detailed above, the Appellant has agreed to withdraw his appeals in CS 9307 and CS 9438.

WHEREFORE, the parties, through undersigned counsel, agree to the terms stated herein as confirmed by the signature of their counsel below, and request that this Agreement be presented to the Commission at its next scheduled meeting.
