AGREEMENT

NOW COME the parties herein, the Department of Public Works ("DPW") through undersigned counsel, and the Appellant, Stacy Warren, Pro Se, who represent that an agreement has been reached resolving the above-captioned Civil Service ("CS") appeal, in lieu of and prior to the CS hearing on March 21, 2023.

DPW's Offer of Resolution:

Based on the removal of any time restrictions by Warren's treating physician on January 16, 2023, on her ability to stand and walk, as required for a Parking Enforcement Officer, Stacy Warren was returned to full time status as a Parking Enforcement Officer on February 13, 2023, working Monday thru Friday, from 9:00 a.m. to 5:00 p.m., as an eight (8) hour employee. DPW has also agreed to provide back pay for the four (4) week period of January 15, 2023 thru February 11, 2023, and all emoluments (leave and retirement benefits) owed to Warren based on her effective reinstatement date of January 15, 2023.

Warren's Acceptance of DPW's Offer and Withdrawal of Appeal

In response to DPW's offer of resolution, to provide four (4) weeks of backpay (January 15, 2023 thru February 11, 2023), and emoluments associated with that period of backpay, with

an effective reinstatement date of January 15, 2023, as stated above, Ms. Warren, has agreed to withdraw her appeal in this matter, as confirmed by her signature below.

WHEREFORE, the parties confirm their agreement to the terms of resolution as stated herein, by their signatures below, requesting this Agreement be presented to the Commission at its next meeting.
