#### **AGREEMENT**

NOW COME the parties - Appellant, Tyrone Dukes, and the Appointing Authority, New Orlcans Police Department (NOPD) - through undersigned counsel, who represent that they have agreed to resolve the above-captioned matter prior to and in lieu of proceeding with the hearing scheduled for August 29, 2023, pursuant to Civil Service Rule II, Section 6.7.

Specifically, NOPD has agreed to reduce the disciplinary action taken under PIB #2021-0422-R of a three-day suspension for sustained violation of NOPD Chapter 41.3.10 Body-Worn Camera to a Supervisory Feedback Log. The sustained violation will remain, but without disciplinary action. NOPD further agrees to reimburse Officer Dukes the three days of suspension served and all emoluments associated with the three day reimbursement. Finally, Officer Dukes' PIB history will be corrected to reflect modification of the suspension to a Supervisory Feedback Log.

In consideration of NOPD's terms of resolution as detailed herein, the Appellant agrees to withdraw his appeal in the above-captioned matter.

WHEREFORE, the parties, through their respective undersigned counsel, request that this Agreement reached prior to the scheduled Civil Service hearing be entered into the record and be presented to the New Orleans Civil Service Commission for acknowledgment at its next scheduled meeting.
