ORDER

The Commission heard this matter at its March 3, 2023, regular meeting. The Sewerage & Water Board moved for dismissal of this appeal. After considering the argument of counsel for the Sewerage & Water Board and of Mr. Williams, the appeal is dismissed. Pursuant to La. C.C.P. art. 2126(E)(1), because Mr. Williams failed to pay the estimated costs before December 19, 2022, Mr. Williams abandoned the appeal.

Mr. Williams requested an appeal on October 10, 2022. The Commission granted this appeal. On November 28, 2022, in accordance with La. C.C.P. art. 2126(A), the Department of Civil Service informed Mr. Williams of the estimated costs of appeal. This letter also informed Mr. Williams that the costs must be paid by December 19, 2022, calculated in accordance with La C.C.P. art. 2126(B). Mr. Williams has not requested an extension of time or a reduction of the costs for the appeal. Therefore, because Mr. Williams has not paid the costs of appeal, he has abandoned the appeal.

Therefore, the appeal is hereby DISMISSED.
