






# Code Enforcement Process Map **INSPECTIONS**




#### Total Code Enforcement Inspections Exceeded Target






#### Inspections Backlog May 30 - June 10, 2011

Age of Inspections Backlog Reduction














### Aging of Hearings Backlog Across Periods (5.27.2011 – 6.10.2011)








## Total Demolition by Program






## INAP Total Lot Clearings, May 30 – June 10, 2011





#### Trend of Tires Removed and Disposed









## **Code Lien Foreclosures**








## Sheriff's Sale: Property scheduled for Auction






NORA Total Closings Above Target




NORA Inventory Backlog Reductions
