ORDER

The Sewerage & Water Board moved for summary disposition of Mr. Braxton's disciplinary appeal on the basis that he has no right of appeal as a probationary employee. The Commission heard oral argument from both parties at its regular meeting on December 18, 2023.

The Sewerage & Water Board hired Mr. Braxton as a Water Meter Trainee on September 25, 2023. The Sewerage & Water Board terminated his employment on November 21, 2023. Rule VII, § 1.1, effective August 1, 2023, provides that all probationary periods are one year. Therefore, Mr. Braxton did not complete his probationary period.

Civil Service Rule II, § 4.1 grants a right of appeal to "[r]egular employees in the classified service." A "regular employee" is "an employee who has been appointed to a position in the classified service in accordance with the Law and these Rules and who has completed the working test period." Rule I, § 1(64). Because Mr. Braxton failed to obtain permanent status, he has no right of appeal.

The Sewerage & Water Board's motion for summary disposition is granted.
