NOW COME the parties, through undersigned counsel, who represent that this Second Amended Agreement confirms the original written agreement of counsel that any extensions to the original thirty (30) day period of leave without pay would be confirmed in writing. The original thirty (30) day period of leave without pay began on September 23, 2021 and ended on October 23, 2021. By an Amended Agreement, the original thirty (30) day period of approved leave without pay status was extended for a second thirty (30) day period. As detailed in the original Agreement, during the period of approved leave without pay status, Ms. Fisher remains an active city employee, with health care coverage, and with permanent status as an Office Assistant II, who is eligible to transfer to any other city department with an Office Assistant II vacancy. Further, Ms. Fisher has agreed that during this period while she is in approved leave without pay status, she will actively pursue finding an available Office Assistant II position in order to effectively transfer from the City Council to another department. Finally, it is agreed that if Ms. Fisher is in the process of applying for or transferring to another position at the time this Second Amended Agreement ends on January 31, 2022, the parties, through undersigned counsel, may further extend the time period for transfer in writing.

WHEREFORE, by agreement of undersigned counsel, the period of leave without pay for Udondis Fisher, which began on September 23, 2021, will continue thru and including January 31, 2022. This Second Amended Agreement will be presented to the Commission for acceptance at its next scheduled Commission meeting in January of 2022.
