ORDER

The New Orleans Recreation Department (NORD) moved for summary disposition of Ms. Vachon's disciplinary appeal on the basis that Ms. Vachon has no right of appeal as a probationary employee. At the regular Commission meeting on November 13, 2023, counsel for both parties appeared. NORD moved for a continuance of oral argument of its motion for summary disposition in order to determine whether NORD extended Ms. Vachon's probationary period. Ms. Vachon moved for leave to amend her disciplinary appeal to add an appeal on the basis of discrimination. Ms. Vachon agreed to the continuance, and NORD agreed to allow Ms. Vachon to amend her disciplinary appeal to add a discrimination appeal. Subsequent to the hearing, the parties agreed that Ms. Vachon may file her discrimination appeal on or before December 12, 2023.

Therefore, consideration of NORD's motion for summary disposition is continued to the Commission's December 18, 2023, regular meeting. The Commission grants Ms. Vachon's motion for leave to amend her disciplinary appeal to add a discrimination appeal. Ms. Vachon may assert a discrimination appeal on or before December 12, 2023, and the date of the filing of the discrimination appeal will relate back to the date Ms. Vachon filed her disciplinary appeal, August 9, 2023.
