

AGREEMENT

The parties herein, through their respective counsel, have reached an Agreement to resolve *Cramer Hanberg v NOPD, CS 9465*, pursuant to Civil Service (CS) Rule II, Section 6.7, prior to and in lieu of proceeding with the CS appeal hearing scheduled for August 1, 2023.


The New Orleans Police Department ("NOPD") has agreed to rescind the thirty (30) working day suspension issued under PIB 2020-0257-R, remove the disciplinary letter from Officer Cramer's personnel file, reimburse him for the five (5) working days of suspension served to date and all emoluments (leave and retirement benefits) associated with the reimbursement of five (5) working days, and correct his Public Integrity Bureau (PIB) short form to indicate recission of the sustained violation of Rule 2, paragraph 6, and recission of the thirty (30) working day suspension. NOPD's terms of resolution are confirmed by the signature of counsel of record below.

In response to NOPD's offer of resolution, as stated herein, the Appellant, Officer Cramer Hanberg, has agreed to withdraw his appeal, as confirmed by the signature of his counsel of record below.


