## 2022-2026 CAPITAL IMPROVEMENT PLAN

Section 1: Introduction and Summary of Recommendations



#### Purpose of the Capital Improvement Plan

The Capital Improvement Plan (CIP) is a five-year program for expenditures by the City of New Orleans for permanent physical improvements. The CIP is prepared and adopted annually by the City Planning Commission and is presented as a recommendation to the Mayor and the City Council. Each year, the plan identifies the physical needs of the City's agencies, estimates the costs of proposed projects, and recommends expenditures and sources of funding for priority capital improvements. As such, the CIP plays an integral role in the process of formulating the City's annual capital budget.

Projects considered through the CIP process involve proposed investments in the City's infrastructure and facilities, such as streets, police and fire stations, parks and recreation facilities, libraries, community centers, offices, sanitation facilities, museums and cultural facilities. Although not defined in the Home Rule Charter, capital improvements are referred to there as "permanent physical improvements" and have conventionally been considered by the City as improvements that are expected to have a normal life of ten years or longer.<sup>1</sup> Equipment and objects needed for day-to-day use by City agencies are generally not considered capital improvements. Smaller projects and projects that are intended to last for fewer than ten years are funded through the City's operating budget.

#### Legal Foundation

The City Planning Commission is required under Section 5-402 (4) of the Home Rule Charter of the City of New Orleans to prepare the City's capital improvement plan and to assist the Chief Administrative Officer in the preparation of the annual capital budget. The Home Rule Charter further requires that the capital improvement plan and the capital budget be consistent with the City's Master Plan.

#### **CIP Development Process**

#### Process Overview and Submittal of Funding Requests

Beginning in May of 2021, each agency of the City was asked to meet with representatives of the Capital Projects Administration for assistance with the preparation of capital budget requests. On June 14, the Capital Projects Administration transmitted copies of all completed capital budget request forms to the City Planning Commission staff. Each request form included the reasons for each proposed improvement project, its estimated acquisition and construction costs, the estimated costs of annual operation and maintenance for the facility, the proposed dates of initiation and completion of the project, the source of funding required for the project in each of the following five years, and the agency's priority rating for the project. The priority rating is based on scores assigned by the agency for each of eighteen rating categories, including *Public Health and Safety, Percent of Population Served by Project, Availability of Financing, Relation to Adopted Plans, Environmental Quality and Stormwater Management, and <i>Public Support*, among others.<sup>2</sup>

#### Master Plan Consistency

The Home Rule Charter requires that the capital improvement program, the capital budget, and any decision to construct a capital improvement must be consistent with the City's Master Plan. The Charter specifically states that any decision to construct a capital improvement is consistent with the Master Plan if it: a) furthers, or at least does not interfere with, the goals, policies, and guidelines, including design guidelines, that are contained in the Land Use Element of the Master Plan; and b) is compatible with the proposed future land uses, densities, and intensities designated in the Land Use Element of the Master Plan. Therefore, all proposals must be certified by the City Planning Commission as consistent with the Master Plan's Future Land Use Map (FLUM) in order to be recommended for funding. Proposed projects without a specific location address may also be supported by goals and policies of other elements of the Master Plan, including those pertaining to environmental quality, green infrastructure, economic development, community facilities and infrastructure, and transportation.

In addition to meeting the FLUM designation, proposed projects must also comply with all regulations within the Comprehensive Zoning Ordinance (CZO). A proposal's location will determine whether a site allows the proposed facility within the base zoning district. Some requested capital improvements in this year's CIP, such as land acquisition and new construction of a public safety facility may trigger the need for approval of a conditional use permit depending on the selected site. Further details such as the location of a site or the extent of a renovation will determine if a conditional use is needed. Proposed projects that may require a special land use approval are detailed with a footnote with more information in this report. Where no location is proposed for a requested facility, Master Plan consistency can only be certified with respect to policies supporting the proposed improvement. Funds for property acquisition may be recommended, but the specific location and design of the proposed facility must be certified by the City Planning Commission prior to undertaking the project.

Public Hearings with Requesting Agencies

City Planning Commission staff held public hearings on June 23 through July 8 with representatives of each agency that submitted a request. The hearings were intended to provide further background information on each proposed project, answer questions, and obtain input from the public. On September 17, the Chief Administrative Officer provided the City Planning Commission staff with a statement of the funds that were likely to be available for capital expenditures between 2022 and 2026, including federal and state grants, FEMA reimbursements, general obligation bonds, and miscellaneous capital funds generated from the sale of City property.

### City Planning Commission Staff Analysis and Draft Plan Preparation

The City Planning Commission staff then performed a detailed analysis of the requests and prepared the draft Capital Improvement Plan. This year's CIP is the product of strong collaboration between the staff of the City Planning Commission and the staffs of the Capital Projects Administration, the office of the Deputy Chief Administrative Officer of Infrastructure, and each of the agencies that submitted a capital improvement proposal. The City Planning Commission will forward this plan to the Mayor on October 15<sup>th</sup> as directed by the City Code. Upon receipt of the CIP, the Mayor will prepare a message to the City Council setting forth her recommendations, which will be transmitted by the Chief Administrative Officer along with a proposed capital budget ordinance for 2022. The City Council will consider the CIP and will adopt a capital budget for 2022.

Throughout the plan, the City Planning Commission's recommended actions are indicated by three different abbreviations. The symbol "A" indicates that funding for the proposed project is recommended for approval in the amount listed for 2022. The symbol "CR" indicates that capital funding is recommended to be held in reserve for appropriation in a capital budget ordinance for one of the future years in the plan. The symbol "D" indicates that funding for the proposed project is recommended to be deferred beyond the period of the five-year capital improvement plan.

#### **Capital Improvement Plan Funding Sources**

The proposed 2022-2026 Capital Improvement Plan has a total source of funds of \$418,415,900. This figure constitutes the sum of five separate funding sources. The amount of each funding source by year is provided in Section 2.1 of the Capital Improvement Plan report. A brief explanation of each funding source is provided below.

#### General Obligation Bonds

On November 16, 2019, city voters approved the issuance of \$500 million in general obligation bonds. The amount of bonds that can be issued is based on anticipated collection rates, assessed values of taxable real estate in the city, and anticipated interest rates. The categories for projects approved under this proposal includes infrastructure improvements, public buildings, affordable housing, recreational facilities, public safety equipment, and all necessary land and equipment for said improvements.

In August 2021, the City sold \$374 million in general obligation bonds. This represents 75 percent of the total amount approved by voters in 2019. These bonds will be allocated to projects approved in the 2021-2025 Capital Improvement Plan. The bond funding recommendations shown in this report are the result of discussions between the City's administrative departments, Councilmembers, and City Planning Commission staff during the Capital Improvement Plan process. As funding for this recent bond sale was appropriated in last year's 2021 CIP, no projects are recommended for general obligation bond funding in this year's CIP.

#### FEMA Reimbursement Funds

Federal Emergency Management Agency (FEMA) Public Assistance funds continue to constitute a large source of funding in this year's Capital Improvement Plan. Because obligations from FEMA are revised on an ongoing basis, project budgets fluctuate and amendments to the capital budget ordinance are necessary throughout the year. On December 10, 2015, the City and the Sewerage & Water Board announced a final settlement with FEMA that included \$1.2 billion in previously unobligated funds, bringing the total settlement amount to \$2 billion in recovery funds. The total forecasted amount of FEMA reimbursement funds in this CIP is \$285,000,000. This funding is projected to come from reimbursements for street repair projects under the Recovery Roads Program. The Department of Public Works has projected to continue spending down these FEMA funds to repair and replace roads through the remainder of 2021 and 2022.

#### Self-Generated Funds

In addition to the sources listed above, some City agencies obtain funds for capital improvements from other sources, including self-generated revenues and federal and state grants. The French Market Corporation generates revenues from leases and other fees that are sufficient to entirely fund their planned capital improvements. These funds are designated "FMC" within this plan. The New Orleans Aviation Board also raises funds through user fees, in addition to federal and state grants and general airport revenue bonds, all of which can only be used for airport-related projects. Projects using these funds are indicated in this plan with the abbreviation "NOAB."

#### Miscellaneous Capital Funds and State Capital Outlay Funds

Two other funding sources are also utilized for capital improvements and indicated with the following abbreviations: State Capital Outlay Funds (SCO) and Miscellaneous Capital Funds (MCF). SCO funds are provided by the State of Louisiana to government subdivisions to fund specific capital improvements as indicated in an annual Act of the State Legislature. For 2021, SCO funds total \$2,360,900 which will be split amongst the Department of Property Management, NORD, and Parks and Parkway. NORD will receive \$150,000 to fund various facilities that may include playground equipment replacement, HVAC replacement, Playground Safety Surfaces, and Pool Renovations. NORD will pick which facilities will receive upgrades based on an ongoing list of which sites are in need of the most repairs. The Department of Property Management will receive \$1,000,0000 that will be used for beginning phases of renovations to the old VA building to support City functions that will include a new roof and life safety systems. The Department of Parks and Parkway will receive a total of \$1,210,900 to fund new shelters at the Joseph Bartholomew Golf Course and to continue with plans for a soccer complex on the West Bank at Brechtel Park.

MCF are other funds received and held by the City for capital improvements and generally consist of proceeds from the sale of City-owned property. They are not a major source of capital funds and are expected to amount to \$500,000 for most years included in this report and are typically recommended for use by the Department of Property Management to continue with repairs and general maintenance on City-owned property.

#### **Overview of the 2022-2026 Capital Improvement Plan Recommendations**

An overview of recommended capital improvement expenditures by program grouping is provided in Section 2.5 of the plan report. Highlights of the funding recommendations for each program grouping are presented in this section. As this year's report comes out directly after \$300 million in bonds have been sold, many of the projects for this year's request appear as unfunded. All additional projects will continue to receive a "D," Deferral recommendation as the City continues to spend down recently sold bonds before the next bond sale.

### Street Improvement Projects

Street improvement projects by the Department of Public Works continue to make up the largest portion of the CIP, with a total expenditure of \$285,000,000. DPW continues to spend down funding FEMA reimbursement funds which accounts for their total proposed funding. In 2014, the City selected a consultant to perform a pavement condition assessment of all City-owned streets. This data was collected in 2015 and a report was submitted to the City in the summer of 2016. The report ranks the condition of all the City's streets from "Very Poor/Failure" to "Excellent." These pavement condition ratings will be used in combination with existing eligible Hurricane Katrina related damage to plan currently funded roadway capital improvements. The pavement condition rating database will then be updated by Department of Public Works staff to reflect work completed and will measure the impact of the work performed. Completed and planned street improvement projects can be monitored at <u>roadwork.nola.gov</u>, which provides a comprehensive look at the City's street program and regular updates on the progress of projects. In last year's report, additional bond funds will go to fund major streets and roadway improvements that were not included in any post-Katrina recovery, and will fund projects in areas of the city that were not damaged as heavily with flooding. In addition to these FEMA reimbursement funds, bond funds from this recently August 2021 sale will be allocated to DPW to make immediate changes to street right-of-ways in response to COVID-19 to increase social distancing and safety measures for pedestrians which were approved in last year's recommendation. These recent bond funds will also go to fund a hazard mitigation projects in the Broadmoor Neighborhood and Duncan Plaza to complete stormwater projects for those areas.

#### Airport Improvement Projects

The second largest category of funding, totaling \$125,000,000, in the CIP is for the Louis Armstrong New Orleans International Airport, which is operated by the New Orleans Aviation Board. The Aviation Board's funding, which is entirely self-generated, has in recent years been mostly dedicated to the construction of the new terminal. With the recent completion of that project, the Board's funding for the next five years will go towards the rehabilitation of taxiways and runways, and the reuse and redevelopment of the old terminal into aviation uses such as maintenance, repair, and overhaul facilities.

#### Parks and Recreation Facilities

Recommended funding for parks and recreation facilities totals \$1,360,900 in SCO funds. These funds are allocated amongst NORD, and Parks and Parkway. NORD will receive \$150,000 in SCO funds that will go towards general improvements and repairs to parks, playgrounds, and recreation facilities. Parks and Parkway will receive \$300,000 for the construction of a new 525 square foot golf course shelter at Joseph Bartholomew Golf Course. Another \$910,900 in SCO funds will go to fund the beginning phases of the West Bank Soccer Complex. The complex will exist at Brechtel Park and the City currently has design proposals that are ready for an RFP for construction that will act as a public/private partnership.

#### **Public Safety Facilities**

This year's CIP includes no additional funding for public safety facilities, however, the 2021 CIP recommended over \$31 million in projects for public safety facilities for 2021 bond funding.

#### Libraries and Museums

No funding is recommended in this year's 2022-2026 Capital Improvement Plan for library and museums. While there is no new funding or additional 2021 bonds allocated to this program grouping, over \$6 million bond funds were allocated last year. With the recent bond sales in August of this year, funding will be available this year for much needed repairs and upgrades.

#### Other Public Facilities

A large portion of the funding for other public facilities will come in the form of self-generated funds from the French Market Corporation that will be used to maintain and improve the French Market and the Upper Pontalba Building. Property Management is responsible for maintaining City facilities past their warranty period and oversees repairing a number of aging facilities throughout the City. Miscellaneous Capital Funds will continue to fund these on-going building repairs, life safety upgrades, and energy efficient upgrades. Last year's recommendation funded a variety of other public facility projects throughout the city that are still slated to receive funding with 2021 bonds.

#### Affordable Housing

The Affordable Housing program group was new to the Capital Improvement Plan in 2020, and is a result of the 2019 bond referendum which specifically proposed to allocate bond funding towards affordable housing developments. Last year's plan allocated \$15 million towards various housing developments throughout the City. No new funds or projects were proposed for this year from The Office of Community Development. These projects will receive funding over the next several years and some have started the beginning design phases. Christopher Park in Algiers on Murl Street has come through the City Planning Commission as a design review and has undergone comments from the Design Advisory Committee. As many of these projects will require additional zoning or design entitlements, City Planning Commission staff will work closely with the administration and developers involved as these projects come to fruition. A description of the nine proposed projects from the 2021-2025 plan is provided in the Future Capital Program Priorities section of this introduction.

#### **Future Capital Program Priorities**

In previous years, due to an absence of a bond funding, the City Planning Commission deferred the majority of capital requests listed in the CIP. With a bond sale that occurred in August of this year, slightly later than previously anticipated, funds from this recent sale will go to projects approved in the 2021-2025 report. With these recent bond sales, the City will be able to fund many of the projects that have been deferred over the past several years. Many of these projects have come before the City Planning Commission in previous CIP requests and highlight the need of all departments throughout the City. In anticipation of the future availability of bond funding, the City Planning Commission developed priorities for future capital investment. The majority of projects presented in this year's report will be deferred in anticipation of future bond sales.

The City Planning Commission continues to recommend five priorities for the city to focus future funding efforts: 1. Investment in Streets and Stormwater Management, 2. Repair and Replace Public Safety Facilities, 3. Make Projects Whole, 4. Develop an Asset Management System and Consolidate City Facilities, and 5. Work with the Administration to Develop Housing Priorities. Many of these five priorities are reflected in the capital requests that recommended to receive funding in 2021 or later. Each of these priorities discussed below with a brief highlight of funded projects.

#### 1. Continue Investment in Streets and Stormwater Management

The City continues to improve streets and drain infrastructure by spending down FEMA reimbursement funds and prioritizing additional stormwater management projects. The Department of Public Works is recommended to receive the largest allocation of funds, FEMA reimbursements which are leftover from repairs to streets and roadways after Hurricane Katrina. These projects include total reconstruction of streets with new sidewalks, curbs, and additional street infrastructure when required. The Department of Public Works as well as other city agencies such as various parks and facilities continue to switch to green infrastructure by providing stormwater management in their overall design proposals. Pervious paving and bioswales are becoming part of the regular street infrastructure throughout neighborhoods. The Gentilly Resilience District is still in planning phases, but continued community meetings are making progress in moving these projects forward.

#### 2. Repair and Replace Public Safety Facilities

Many of the City's public safety facilities are still in need of upgrades on account of their age and a history of deferred maintenance. The 2021-2025 CIP recommended approximately \$31 million in General Obligation Bonds to fund public safety facilities. With the most recent bond sales, funding will begin to be allocated to replace and renovate various NOFD stations throughout the City.

#### 3. Make Projects Whole

In prior years, there were a number of projects that were submitted during the CIP process that have already received partial funding for preliminary planning or design work, either from former bond funds or through donations and grants. More agencies this year have submitted

requests for funding portions of projects slated for additional grant funding. The New Orleans Municipal Traffic Court has submitted a funding request to help match grant funding for a new community court. The New Orleans Building Corporation continues to request matching funds for Union Passenger Terminal to make upgrades to the current rail and bus facilities which will receive some funding from Amtrak and through a State of Good Repair grant.

#### 4. Develop an Asset Management System & Consolidate City Facilities

In years prior, the Department of Property Management and the CAO's Equipment Maintenance Division submitted a capital request for an asset management and work order system. The Chief Technology Officer within the Chief Administrator's Officer's office also requested a comprehensive asset management system that would work for multiple city agencies, ideally existing as a Citywide system for property, documents, and eventually assist in managing City personnel and training. Approximately \$2,500,000 of the 2021 bond sales will go towards funding these systems. EMD will also use portions of this system to track movable property within the city. This year's requests between NOHSEP and EMS for a joint warehouse facility also show an effort to consolidate city facilities to better utilize existing assets and funding. NOHSEP and EMS have similar warehousing needs as both respond to disasters and need better storage for safety equipment and have together identified an existing site that could meet both department's needs. Additional requests for storage and records retention continue to make up a bulk of the requests in the 2022-2026 plan. The DA, NOPD, and Clerk of Criminal Court have also requested records retention storage in some capacity. While the security needs for records storage between these departments may vary, renovating more of the VA building to help store records and fill in needed office space for various departments will help fill some of these needs.

#### 5. Work with the Administration to Develop Housing Priorities

The 2019 bond referendum listed "affordable housing facilities as one of the categories of projects the proposed bond funding would be allocated towards. Voters approved this new expenditure category and last year the city's Office of Community Development has identified nine sites throughout the city in each council district which will receive funds to assist in purchasing and building these developments. Last year, nine sites were identified by the Office of Community Development. Based on the number of units for specific projects, many, if not all of these proposals could need additional zoning entitlements that would require further review by the City Planning Commission at a public hearing. The sites that do not have a specific location would need to meet the base zoning district regulations in addition to matching the FLUM consistency in the Master Plan. Some of these projects have started to come through the City Planning Commission for various zoning and design review.

### **Ongoing Capital Improvement Projects**

According to figures by Capital Projects Administration and the Department of Public Works, as of September, 2021, the City has 67 active non-street capital projects with a cost of \$238,728,209 and 229 street-related capital projects with a cost of \$1,576,490,491. Overall, this amounts to a total of 296 projects with a total cost of \$1,815,218,701. Detailed lists of all ongoing projects are provided in Appendices I and II. Some noteworthy projects which are completed or are continuing to spend funds from previous years are described in more detail on the following pages.

Location: 3900 Alvar Street

Funding: \$6,248,051

Construction has started on the new 16,733 square foot maintenance garage and offices for the City of New Orleans Equipment Maintenance Division. While the city will continue to operate portions of the older facility, this new facility will be used to house administrative staff and aid in the repair and maintenance of City-owned vehicles and equipment. Repairing vehicles and equipment with City-owned resources helps cut operating costs and helps extend the lifespan of vehicles and specific equipment.

**Project:** Gallier Hall is undergoing its third phase in restorations with both interior and exterior historic preservation and upgrades. Exterior renovations include new exterior lights and shutter repair and repairs to the chiller room. The interior of the building is undergoing floor refinishing, new interior lighting, and updates to the existing kitchen facilities. The restoration of Gallier Hall will protect a historically significant landmark within the city.

#### Location: 2761 Gravier Street

#### **Funding:** \$25,117,485

Construction of the new Criminal Evidence and Processing Facility for NOPD continues. This project includes a new five-story criminal evidence and processing facility which will total approximately 64,000 square feet in area. The new facility will be used by the Criminal District Clerk of Court, the Municipal Court, and NOPD to house and process evidence. Once completed, NOPD's crime and DNA labs will exist in this new facility.

#### Location: Citywide

Phases of the Gentilly Resilience District are in planning stages for implementing various stormwater management projects throughout Gentilly. These projects are currently undergoing community meetings to gather input from neighbors and various city and community stakeholders. Figures 5 and 6 depict current conditions and a proposed rendering of a streetscape before and after stormwater management features are installed to improve drainage and reduce flooding in the neighborhood. Increased permeable surfaces through permeable parking spots, new bioswales, and additional tree plantings will all aid in reduced flooding.

The Dillard Wetlands is another project undergoing design phases within Gentilly. Located across from Dillard University, is a 27-acre undeveloped woodland owned by the City of New Orleans with long-standing tree growth. Plans include removing invasive species within the native live oak tree canopy and palmetto understory, increasing wetland capacity to hold rainwater, and creating amenities for the community to eventually access the site and use it for recreation and educational opportunities.




Figure 7: Conceptual Plans for Dillard Wetland



### Non-DPW or Airport Capital Improvement Requests, 2022 - 2026

The Department of Public Works road repair and reconstruction program and the construction of the new Airport terminal have represented the vast majority of capital funding requests in recent years' Capital Improvement Plans. After the completion of the new airport terminal, the Public Safety and Parks and Recreation categories represent the reamining majority of requests.

The remaining 30 percent represents funding requests for City facilities such as parks, museum, other public facilities. The bond funding approved by voters last year will address many critical capital needs for the City, but additional funding will be needed to fulfill all of the capital requests projected for the next five years. The chart to the right shows the total capital request amounts for all non-DPW or Airport departments and agencies.



















#### Opposition to any funding or allocations toward the proposed City Hall at Municipal Auditorium Capital Improvement Project

Dear Commissioners,

The Save Our Soul Coalition (SOS) is dedicated to the protection of sacred Congo Square, the preservation of Louis Armstrong Park, and the restoration of Municipal Auditorium to it's historic and traditional use as an essential element of our community's cultural infrastructure.

We understand the City Planning Commission is preparing a 2022-2026 Capital Improvement Plan (CIP) in accordance with the Home Rule Charter, to assist in the preparation of the City's annual capital budget. Save Our Soul Coalition wishes to express our deep opposition to any funding allocations toward planning, or redevelopment of Municipal Auditorium as a new City Hall. Instead, we urge the Administration, the Planning Commission, and the City Council to take all necessary steps toward funding immediate stabilization, repair and restoration of Municipal Auditorium to historic cultural use it has been devoted, and dedicated since 1930.

The historic boundaries of Congo Square must be respected as sacred ground with profound spiritual and historic meaning not only for New Orleanians but for people across the African diaspora. Louis Armstrong Park must remain an appropriate memorial to one of New Orleans most important native sons and most consequential pioneer of one of America's only original art forms: Jazz. This site is a dedicated public park, created and devoted to the memory of Louis Armstrong. We are opposed to this Administration's proposal to divert a significant portion of this dedicated public park to another unrelated purpose.

#### The proposed Capital Improvement Project is prohibited by the Protect Tremé Interim Zoning District.

On July 1, 2021, the New Orleans City Council adopted Motion No. M-21-228 prohibiting City Hall or Government Offices within Louis Armstrong Park. This prohibition is effective immediately upon adoption of the motion. A City Hall at Municipal Auditorium within Congo Square/Louis Armstrong park is in violation of the Interim Zoning District

#### The proposed Capital Improvement Project violates the Home Rule Charter and Master Plan

The language of the Home Rule Charter is clear and unambiguous. It mandates, any "decision by local government to construct a capital improvement," "capital improvement plan," or "capital budget" "<u>shall</u> be consistent with the Master Plan." The word "shall" is mandatory, not discretionary. The Home Rule Charter further mandates all land use actions must "further, or at least not interfere with, the goals, policies, and guidelines of the Land Use Element of the Master Plan," and be "compatible with proposed future land uses, densities, and intensities designated in the Land Use Element of the Master Plan," and "no public project or facility and no public utility, whether publicly or privately owned, shall be authorized or significantly altered except in conformity with the adopted Master Plan."

The proposed Capital Improvement Project is in direct conflict with the Goals, Range of Uses, and Development Character of Parkland and Open Space Future Land Use Map designation (FLUM).

The Future Land Use is the single most important element of the Land Use chapter of the Master Plan. A city hall or an immense principal institutional government office use, is neither contemplated or permitted. Only ancillary or park-supportive uses are allowed as a limited exception.

#### PARKLAND AND OPEN SPACE

**Goal:** *Provide areas for parks, recreational facilities and open space networks owned by public or semipublic entities while offering the opportunity to utilize such spaces for stormwater management measures.* 

**Range of Uses:** *Parks, playgrounds, recreation facilities and athletic fields; neutral grounds and passive open spaces, agricultural uses, rain gardens, bioswales and other stormwater management measures. In large parks, a variety of passive and active recreation facilities, cultural facilities, and supportive commercial uses may be allowed.* 

**Development Character:** Ranges from programmatic parks and indoor and outdoor recreational areas to preserved open space, with the opportunity to provide for stormwater management measures. Incorporate risk reduction and adaptation strategies in the built environment.

The proposed City Hall relocation to Municipal Auditorium promises to degrade the residential fabric of surrounding neighborhoods and inflate nearby property values, placing an even greater pressure on fragile communities. It promises to overwhelm Louis Armstrong Park and adversely impact passive recreation, reflection and enjoyment of the park. The proposal promises long-term adverse impacts which will spur intense out-of-scale development similar to that which exists surrounding current City Hall. The proposal threatens increased traffic and congestion, walkability, and the health and safety of residents and visitors alike. It would inflict another wound on the Tremé community and culture already scarred by a century of appropriation, inequitable and poor governmental planning and actions.

### The proposed Capital Improvement Project is inconsistent with additional Goals, Strategies, and Policies embedded within the Land Use Element of the Master Plan:

- Conserve the character of historic and special places
- Preserve existing parks;
- Preserve the character of existing surrounding residential neighborhoods;

• Create a Crossroads of Cultural Tourism by supporting clustered development of museums and cultural venues by creating a district for these uses and supporting retail and visitor services that promote the arts.

• Establish appropriate transitions between high impact, medium impact and low impact development;

• Expand City's public art program and strengthen the relationship between the City and the arts and cultural community to help secure additional funding for public art, and to provide opportunities to access and participate in artistic and cultural events and offerings;

• Promote walkability• Preserve and expand parks and public spaces and ensure a balance of passive and active uses; Ensure a balance of passive and active recreational uses in regional parks;

In closing, we repeat our request that the city prioritize all necessary funding toward the immediate stabilization, repair and restoration of Municipal Auditorium to its traditional use, as an essential element of our community's cultural infrastructure.
