

MAYOR'S OFFICE OF CRIMINAL JUSTICE COORDINATION

Introduction

Currently, the OCJC allocates money to grantees with funding from Edward Byrne Memorial Justice Assistance Grants from the State (Byrne JAG – State), Edward Byrne Memorial Justice Assistance Grants from the Federal Government (Byrne JAG – Federal), State Victims of Crime Act (VOCA) Grants, Violence Against Women Act (VAWA) Grants, and State Office of Juvenile Justice and Delinquency Prevention. The amounts, grantees and types of programs are listed below for fiscal years 2010-2013:

Byrne JAG – State

Amount: \$887,813

Grantees: Criminal District Court, NOPD, Orleans Parish Sheriff's Office, Orleans Parish District Attorney, New Orleans Health Department

Types of Programs: Byrne JAG state grants are currently supporting overtime for relevant NOPD task forces; drug testing and interventions; job training at OPP; and youth violence programs.

<u>Byrne JAG – Federal</u>

Amount: \$435,497

Grantees: Orleans Parish Sheriff's Office, Municipal Court, Orleans Parish Sheriff's Office, Orleans Public Defenders, NOPD, Mayor's Office

Types of Programs: Byrne JAG federal grants are currently funding correctional surveillance; drug treatment and evaluation; technology upgrades; and a federally mandated program for representing juveniles charged as adults.

<u>VOCA</u>

Amount: \$765,769

Grantees: Metropolitan Center for Women and Children, New Orleans Family Justice Alliance, CASA, Catholic Charities, Children's Bureau, Children's Hospital, Civil District Court, District Attorney's Office, Family Service of Greater New Orleans

Types of Programs: VOCA grants are currently funding counseling and treatment programs for victims of domestic violence, child abuse, and sexual assault; and legal assistance to victims of domestic violence.

<u>VAWA</u>

Amount: \$175,695

Grantees: NOPD, District Attorney's Office

Types of Programs: VAWA grants are currently funding overtime for the NOPD Sex Crimes Unit, and legal assistance, counseling, and screening for domestic violence cases.

OJJDP

Amount: \$90,071

Grantees: APEX Community Advancement, Inc., and Juvenile Regional Services

Types of Programs: OJJDP grants are currently funding a youth resource center and a recidivism reduction program.
