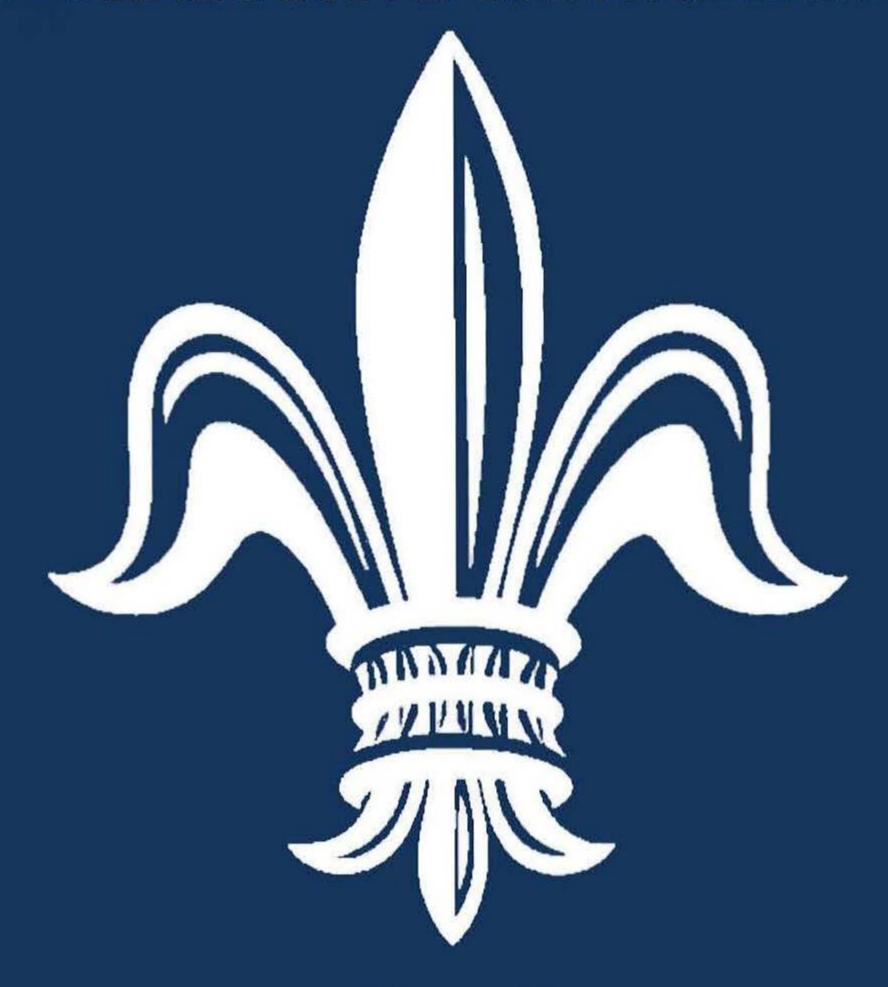

#### To My Fellow New Orleanians:

Over the past seven years, we have taken enormous strides to get this city on the right path. In partnership with the City Council and based on important feedback from you, we have identified priority capital recovery projects in each council district, from community centers to pools to playgrounds to vital public safety infrastructure to drainage and streets. As additional FEMA funds have been awarded, we were able to add even more projects to that thoughtful list.

Since taking office, my administration has met with FEMA over 900 times, producing over \$2 billion more in recovery assistance for the City and the Sewerage and Water Board to repair buildings and critical infrastructure like water lines and streets. This year's Capital Budget reflects committed funding for those projects.

In this 2018 Capital Budget of close to \$692 million, every dollar will be affiliated with a project or program. We are budgeted to move forward on dozens of public facilities like the construction of a new fire station in Algiers, construction of a new NOPD 4<sup>th</sup> District Police Station, repurposing the Lafitte Greenway brake tag station into an out-door pavilion, and \$421 million in road repairs, drainage, sewerage, water line and stormwater management projects. This is on top of our already large number of ongoing improvement projects like construction of the new terminal facility at Louis Armstrong New Orleans International Airport, interior renovations at the Criminal District Court, Algiers Courthouse restoration, Municipal Yacht Harbor in West End, the Gert Town Natatorium, the NOPD 2<sup>nd</sup> District Police Station, and the redevelopment of the City's riverfront.

We are on the right track. With our continued progress, New Orleans is developing into a city of opportunity, with safe neighborhoods, quality schools for all of our children and good-paying jobs here at home.

This 2018 Capital Budget helps us continue to build on our progress and lay a stronger foundation for the future.
