Mayor Cantrell's Capital Budget Message



November 1, 2022

To My Fellow New Orleanians:



We are living in uncertain times and while it has been a challenging year, our city and our people persevere. Our economic recovery from the COVID-19 global pandemic continues to progress, despite profound impacts to our capital infrastructure program from materials cost increases, supply chain issues and an increasingly tight labor market.

As our capital budget is developed, we remain focused on addressing our most pressing problems of today while building a strong and successful foundation for generations to come.

Strategic capital investments in replacing aging infrastructure and pushing our city toward a more resilient and sustainable future has led to an unprecedented amount of work on our vertical and horizontal infrastructure projects.

Our 2020 bond sale of more than **\$370M** is the largest, one-time new money bond sale in our city's history and is functioning as a local stimulus to rebuild infrastructure and infuse funding into our economy all at the same time. These bonds are allowing us to use existing millage rates to repair our streets and drainage lines, build stormwater management projects and affordable housing, as well as improve our public spaces. These investments are on top of the more than \$1.6B in FEMA-funded joint infrastructure work under way across the city.

Since May 2018,142 roadwork projects have been completed, valued at **\$493.25M** dollars and another 54 are under construction valued at approximately **\$607.28M** dollars. We will be kicking off construction on **about \$432.30M** worth of projects in early 2023 and there are another 78 projects that are in final design worth **\$463.35M**.

Likewise, our Capital Projects Administration (CPA) has completed 80 vertical infrastructure projects since 2018 valued at **\$197.4M**. In the last year, CPA has completed 21 public facilities projects totaling **\$72.6M**, including the Platt Playground Canopy, NOPD Firing Range, Criminal Evidence Processing Center and the Village D'Lest Multipurpose Building. And we will soon be kicking off projects like the Morris FX Jeff Sr Pool Renovations, NOPD 4th District Station Renovations and the NOFD 8th District Headquarters.

We are simultaneously building upon lessons learned by investing in projects that utilize parks, vacant land and innovative streetscaping to hold rain during severe weather events while our pumping system catches up.

In partnership with NORA, we have completed more than 200 residential stormwater management improvements through the Gentilly Resilience District (GRD) Community Adaptation Program. More than **\$120M** in GRD stormwater management and recreation infrastructure projects that will bring 20.5 million gallons of stormwater storage are anticipated to be in construction next year, including the **\$42M Blue and Green Corridors Project.** Additionally, our **\$130M** Hazard Mitigation Grant Program will continue with construction kicking off on the **Bayou St. John – Oak Park Green Infrastructure and St. Roch Drainage Projects**, among others.

In partnership with the City Council, this 2023 Capital Budget includes moving forward with **\$1.6B** in critical road repairs, drainage, sewerage, water line and storm water management projects in each council district.

Your continued support and engagement in the budget process is more important now than ever, and I am committed to ensuring that every resident is heard as we continue moving New Orleans forward.
