

Response Times

Reducing GOA Calls For Service

OCDM issued a report in October 2023 in which raised concerns with NOPD response times leading to GOA call designations



دة Enhanced use of Reserve Officers

Draft SOPs and Policy related to response to calls for service were developed

Restored priority modifiers to assist in triaging calls (code 2A-2G)

Revamped "plain talk" to signal codes to allow for greater degrees of nuanced call response.

Continued expansion of APR unit and eligible calls



Addressing GOA calls

We will still have GOA calls, but we have put measures in place to connect to those callers and survivors.

Area of concern

- Sexual Assault calls for service
- Domestic Violence calls for service
- UCR calls for service

NOPD response

- SVD now assigns all GOA cases to a detective for investigation
- All GOA DV calls are called back the following day by civilian investigators. Serious cases are assigned to a DV detective.
- APR calls back all UCR calls for service the following day to attempt to take the caller's report


Mobile Crisis Intervention Unit

- Average of 32% of all Mental Health Calls received by 911 are handled by MCIU
- NOPD still responds to calls with the threat of violence








VIII. STOPS, SEARCHES, AND ARRESTS The Monitoring team regularly reviews police reports, warrant affidavits, and BWC footage to determine whether stops, searches, and arrests (SSA) comply with the law and NOPD policy and whether police reports accurately describe the officer's conduct. This remains an area of concern given repeated findings across audits of possible CD violations in approximately 20% of the BWC videos reviewed.*

NOPD SSA Improvement Measures

- FOB inspections program (2021)
- Daily Training Bulletins / Focused Training at In-Service and recruit training
- Enhanced FIC review of Stops, Searches, Arrests
 - Started May 2023 by Major Michael Pfeiffer (ret.)
 - Educational tool to enhance the quality of documentation of Stops Searches and Arrests
 - Provides immediate feedback on deficiencies to field supervisors and Captains
 - Most of these reviews occur prior to a field supervisors' review
 - Provides targeted training for both Officers and Sergeants
 - 5856 reviews in 2023
 - 700 reviewed in January 2024



Formal Disciplinary Investigations related to Secondary employment and NOPD shift violations

Externally generated complaints for historical violations

- During 2023 NOPD received complaints regarding payroll records dating back to 2016.
- During 2024 NOPD only received complaints regarding payroll records for years prior to 2022

Internally generated complaints April 2023 to present

- Based on the enhanced tracking the department has implemented, NOPD supervisors have initiated 4 FDI-1's for 8 possible violations.
- These possible violations were discovered by the enhanced tracking system developed by the Department in 2023.
