EXPLANATORY NOTES

- 1.) The number in parenthesis immediately preceding each class title in this pay plan represents the occupational code (OC) as defined by the Federal Equal Employment Opportunity Commission for the class of work. These codes are as follows:

1. Officials and Administrators
2. Professionals
3. Technicians
4. Protective Service Workers
5. Paraprofessional
6. Office and Clerical
7. Skilled Crafts Workers
8. Service/Maintenance

This information is required for the preparation of statistical reports by the Management Information System and has no other significance.

- 2.) Under the heading EAP there is a designation "EX" to indicate which classifications are exempt from the Fair Labor Standards Act (FLSA) regulations on overtime. This indicator is provided for informational purposes only and is subject to change.

LONGEVITY PAY INCREASES

All employees in the classified and the unclassified service receive periodic salary increases which are determined by each employee's length of consecutive service.

Listed below is an excerpt from section 8 of Rule IV of the rules of the Civil Service Commission explaining the criteria for granting longevity pay increases to city employees.

"All employees having more than one (1) but less than five (5) years of consecutive service under current employment shall receive two one and one quarter (1.25%) increases over their normal rate of pay.

All employees have more than five (5) but less than ten (10) years of consecutive service under current employment shall receive two one and one quarter (1.25%) increases over their normal rate of pay.

All employees having more than ten (10) but less than fifteen (15) years of consecutive service under current employment shall receive two one and one quarter (1.25%) increases over their normal rate of pay.

All employees having more than fifteen (15) but less than twenty (20) years of consecutive service under current employment shall receive two one and one quarter (1.25%) increases over their normal rate of pay.

All employees having more than twenty (20) but less than twenty-five (25) years of consecutive service under current employment shall receive two one and one quarter (1.25%) increases over their normal rate of pay.

All employees having more than twenty-five (25) years of consecutive service under current employment shall receive two one and one quarter (1.25%) increases over their normal rate of pay.

After having completed the twenty-fifth (25) year of consecutive service under current employment, all employees shall receive two one and one quarter (1.25%) percent over their normal rate of pay and for each ensuing five (5) year segment of consecutive service thereafter."
