The following items will be placed on the consent agenda:

- 407 Tricou St: Construction of a new single-story, single family residential building.
- 1200 Bartholomew St: New construction of a single-story, single family residential building.
- 729 Lizardi St: Reconstruction of a single-story, single family residential building.
- 2304-2306 Carondelet St: Construction of two-story, single family residence on vacant lot.
- 2619-2621 St Thomas St: Construct two-story, single-family residence on existing vacant lot.
- 2623-2625 St Thomas St: Construct two-story, single-family residence on existing vacant lot.
- 1121 1St St: Construct new 630 sf accessory building.

- 1400 Camp St: Replace all existing wood windows with aluminum clad widows.
- 1329 Jackson Ave: Removal of window to install new door with transom.
- 906 Mazant St: Addition of a front porch.
- 531-533 Belleville St: Replace existing 6/6, double-hung wood windows with double-hung vinyl windows.
- 3131-3133 Dauphine St: Appeal of Staff recommendation regarding installation of batten shutters.
- 2715 St Charles Ave: Construct new, two-story accessory building.
- 1239 Desire St: Retention of removal of ridge tiles and retention of installation of inappropriate batten shutters.

- 5121 Douglas St: Retention of inappropriate modifications to the building done without CofA.
