II. Roll Call (1:35)

III. Opening Remarks (1:38)

Elected-Co-Chair Melanie Talia thanked everyone for attending the meeting and thanked the Sheriff's Office for hosting. Ms. Talia explained that Commissioner Stevens was tied up in an earlier engagement but that she would be arriving shortly. She also reviewed the agenda noting

that the group would hear presentations from NOPD, the Ethnic and Racial Disparities Working Group, and the delegation that attended the Safety and Justice Challenge Network meeting.

IV. Consideration & Approval of the Minutes from the August 24th Meeting (1:41)

Melanie Talia asked the members for corrections or additions to the minutes previously distributed. Two corrections were made correcting the presence of Brian Lapeyrolerie as designee for Dr. Dwight McKenna and correcting the name of Council President Moreno's designee, Sayde Finkel.

A motion for approval of the minutes of the August 24th meeting as corrected was made by Ned McGowan and seconded by Diedre Pierce. There were no oppositions, the motion passed.

V. NOPD Progress/ Retention – Deputy Superintendent Jonette Williams (1:45)

Deputy Superintendent Williams gave an update and overview of the progress made by NOPD in the recruitment and retention effort. She noted Class 195 recently graduated with 18 officers and class 196 began with 12 new recruits. NOPD has relaxed personal appearance standards and lowered re-test window for applicants from 6 months to 30 days on the second test attempt. A lateral recruitment program was instituted, which shortens the length of the academy from 26 weeks to 10 weeks for lateral recruits. Seventy-five new vehicles were purchased. NOPD continues to advance civilianization efforts by hiring for Police Investigative Specialists and Police Intake Specialists, as well as deputizing an estimated 20 City employees to handle citations.

VI. Racial Equity Cohort Work Plan – Kate Hoadley, OCJC (1:54)

Kate Hoadley gave an overview of the Racial Equity Cohort grant work. In January 2022, the John D. and Catherine T. MacArthur Foundation invested in four sites poised to go deeper on eliminating racial and ethnic disparities in the criminal legal system. The City of New Orleans and Total Community Action were selected as a partnership to implement a theory of change for racial equity and reimagining safety and justice in New Orleans. The grant will comprise of three phases: 1) empowering change agents through a collective leadership curriculum 2) listen and learn sessions and 3) an action forum.

VII. Grant Updates- Jenny Alber, OCJC Grants Director (2:05)

Jenny Alber, Grants Director, gave an update on grant matters. Victims of Crime Act (VOCA) funding applications were due December 8th. The Grants Division staff conducted a training on grants administration on October 12th.

VIII. Safety and Justice Challenge Network Meeting Update (2:07pm)

Hon. Tracey Flemings-Davillier, Deputy Chief Judge for Orleans Criminal District Court, provided an overview of a workshop that she facilitated during the Safety and Justice Challenge Convening. The workshop was titled, "Engaging with Local Elected Officials to Identify and Eliminate Racial and Ethnic Disparities in the Criminal Legal System." Judge Flemings-Davillier discussed efforts made the Ethnic and Racial Disparity Working Group, the Pretrial Services program, and the Public Safety Assessment to advance equity in the Orleans Parish criminal legal system.

IX. Member and Community Updates (2:18)

Councilmember updates included: Probation and Parole has a new location at 1250 Poydras on the 10th Floor and Sierra Thompson has been named the Interim Chief Public Defender.

There were no community member updates.

X. Closing Remarks & Adjournment (2:27pm)
