AN ORDINANCE to amend Division 7 of Article VIII of Chapter 154 of the Code of the City of New Orleans, to ordain a new section, to be designated as Section 154-984, related to the public safety and enforcement of Mardi Gras parades, to prohibit stopping and parking on certain streets at certain times, and otherwise to provide with respect thereto.

WHEREAS, the people of the great city of New Orleans deserve a Mardi Gras season that is fun and safe; and

WHEREAS, clearer rules promote fair and effective enforcement and thereby promote public safety; NOW THEREFORE

1 SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY
2 ORDAINS, That Division 7 of Article VIII of Chapter 154 of the Code of the City of New Orleans
3 be and the same is hereby amended and reordained to add a new Section, to be designated as
4 Section 154-984:

5 "Division 7. PARKING PROHIBITED OR RESTRICTED.

7 Sec. 154-984. Stopping or parking prohibited on Napoleon Avenue and St. Charles Avenue at
8 certain times.

9 (a) No person shall stop or park a vehicle on either side of Napoleon Avenue between
10 Tchoupitoulas Street and Claiborne Avenue between two hours before and two hours after any
11 Mardi Gras parade whose route includes that portion of Napoleon Avenue.

12 (b) No person shall stop or park a vehicle on either side of St. Charles Avenue between Napoleon
13 Avenue and Canal Street between two hours before and two hours after any Mardi Gras parade
14 whose route includes that portion of St. Charles Avenue.”
