AN ORDINANCE to amend and reordain Article III of Chapter 70 of the Code of the City of New Orleans to add a new Division, designated as Division 31, to be codified in Sections 70-415.244 through 70-415.246 thereof, to create a new fund to be designated as the Police Secondary Employment Fund for the support of the operations of the Office of Police Secondary Employment; and otherwise to provide with respect thereto.

**SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY ORDAINS**

that Article III of Chapter 70 of the Code of the City of New Orleans be and it is hereby amended and reordained to add a new Division thereto, designated as Division 31, codified in Sections 70-415.244 through 70-415.246 thereof, creating a new fund, designated as the Police Secondary Employment Fund for the support of the operations of the Office of Police Secondary Employment, to read as follows:

**“Chapter 70. Finance**

**Article III. Funds.**

**Division 31. Police Secondary Employment Fund**

**Section 70-415.244. Fund created.**

A special fund is established in the Department of Finance, under the provisions of Section 6-207 of the Home Rule Charter, to be known as the “Police Secondary Employment Fund”.

**Section 70-415.245. Funding and Purpose.**

16 All revenues collected by the Department of Finance from the operation of the Office of Police  
17 Secondary Employment shall be deposited into the Police Secondary Employment Fund. Expenditures  
18 from the fund shall be used to fund operations of the Office of Police Secondary Employment.


19 **Section 70-415.246. Reports.**

20 The Director of the Department of Finance shall keep detailed accurate books in the administration of  
21 the fund and shall make reports to the Chief Administrative Officer and the City Council, giving a  
22 complete accounting of revenues and expenditures of the fund annually as part of the annual city audit.”
