AN ORDINANCE to amend and reordain Article III of Chapter 70 of the Code of the City of New Orleans to add a new Division, designated as Division 31, to be codified in Sections 70-415.244 through 70-415.246 thereof, to create a new fund to be designated as the Police Secondary Employment Fund for the support of the operations of the Office of Police Secondary Employment; and otherwise to provide with respect thereto.

SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY ORDAINS

that Article III of Chapter 70 of the Code of the City of New Orleans be and it is hereby amended and

reordained to add a new Division thereto, designated as Division 31, codified in Sections 70-415.244

through 70-415.246 thereof, creating a new fund, designated as the Police Secondary Employment Fund

for the support of the operations of the Office of Police Secondary Employment, to read as follows:
